1. The entering into by the Division of the Education Agreement with the First Nation in the form and content presented by the Chief Superintendent be and is hereby authorized and approved.

- 2. The Chief Superintendent of the Division and any other officer or trustee of the Division be, and they are hereby authorized and directed to execute and deliver the Education Agreement, and that the Education Agreement so executed is ratified and confirmed to be the one authorized by this resolution.
- 3. Any one or more officers of the Division be and they are hereby authorized and directed to do all such further and other acts and things and execute or cause to be executed such further and other instruments, agreements. certificates. acknowledgements, declarations, documents and undertakings, as in their opinion may be necessary or desirable to perform the Division's obligations under the Education Agreement, and to further amend any instruments or agreements previously executed or delivered, all to be in such form and on such terms as they shall approve, such approval to be conclusively evidenced by their execution thereof.
- 4. All actions hereinbefore taken by the Chief Superintendent and any other officer or trustee of the Division in connection with the negotiation, developing and signing of the Education Agreement or the matters authorized by this resolution are hereby ratified, sanctioned, adopted and confirmed.
