The Board discussed and provided direction to administration regarding topics for their meeting with senior leadership (Superintendent Group) planned for October 21-22, 2024. ### **BIRDTAIL SIOUX DAKOTA NATION**

The Board approved a request from the Birdtail Sioux Dakota Nation to terminate the Education Partnership Agreement for services provided at Chan Kagha Otina Dakota Wayawa Tipi School. The termination of the Education Agreement is effective June 30, 2025. Administration was directed to meet with the First Nation to begin the process for this transition.

## MGEU LOCAL 446 COLLECTIVE AGREEMENT

The Board ratified the Agreement Reached-in-Committee between Frontier School Division and the Manitoba Government Employees' Union (MGEU) Local 446 (Churchill) for the period July 1, 2022 to June 30, 2025.

# **POLICIES**

The Board approved recommendations from their Policy Review Committee on the following:

- New draft policy titled "Cell Phone Use" be distributed for comment with a reduced time frame for feedback.
- Revised draft policy titled "Use of Social Media" for feedback with regular time frame for feedback,
- New policy "Staff Interactions with Students" for implementation.

In addition, the Board approved a recommendation from their Finance Committee for an adjustment to mileage rates as identified in Policy D.3.D – Travel Expenses Regulation. Approved policies are accessible in the Policy Manual section on the Division's website.

Administration will be reaching out to other potential committee members to begin this review.
- Standing items (September Board Ŏrientation, Division Office Needs Assessment) were reviewed with discussion on these topics to continue.
- Sample templates to update the Division's Mission Statement were provided for discussion at the October Board meeting.
- Feedback was provided to administration to assist in planning the 2025 Annual School Committee Conference with further discussions taking place at upcoming Board meetings.
